#### Section 2: Why we need your personal information

East Lothian Council provides a range of Adult Services because the law says that we must do this. The services we provide are in the following area:

- Support and advice services for Asylum Seekers
- Support and advice services for Carers
- Community Support including Day centres for disabled people and older people
- Care Services including Older Peoples Residential Care Homes
- Support and advice for those dealing with social issues such as alcohol and drugs dependency
- Supporting Adults who need support from a Social Worker and/or Social Care Practitioner
- Supporting Children with disabilities from our Occupational Therapy Service
- Supporting Adults who need support from our Criminal Justice Service

East Lothian Council is legally required to protect the public funds it administers. For this reason, your information may also be used to prevent and detect fraud, and we may share your information with other organisations responsible for auditing and administering public funds. ## **Section 3: Legal Information**

In order for us to collect and use your information, we have to have a 'legal basis' for doing so. The legal basis for processing your personal information is:

We have a legal obligation to process your information under the following legislation for example:

- Adults With Incapacity (Scotland) Act 2000
- Adult Support and Protection (Scotland) Act 2007
- Crime and Disorder Act 1998
- Criminal Procedure (Scotland) Act 1995
- Disability Discrimination Act 1995
- Mental Health (Care and Treatment) (Scotland) Act 2003
- Social Care (Self-directed Support) (Scotland) Act 2013
- Social Work (Scotland) Act 1968
- Public Bodies (Joint Working) (Scotland) Act 2014
- Welfare Reform Act 2012
- Immigration and Asylum Act 1999
- Community Justice (Scotland) Act 2016
- Community Empowerment (Scotland) Act
- Carers (Scotland) Act 2016
- Children (Scotland) Act 1995
- Children and Young People (Scotland) Act 2014 (this is not an exhaustive list)

We are processing your information as part of our public task as a local authority.

The kinds of personal information we are collecting include:

- a. Name
- b. Previous name
- c. Address
- d. Date of birth
- e. Information about other people, such as emergency contact details, power of attorney, legal guardian
- f. Unique Identifier, such as a Social Work Client ID Number
- g. Medical/health information
- h. Criminal convictions/offences
- i. Racial or Ethnic origin
- j. Religious or Philosophical beliefs

The types of information listed in points g-j above are known as 'special category' personal information. We need an additional 'legal basis' in order to process these kinds of information.

The legal basis for processing your special category information is:

- You have given us explicit consent to process your information.
- We need to process your information to protect your or another person's life.
- We need to process your information to provide social care and to manage health and social care systems and services.



## Section 4: Sharing and transfer

We may share your personal information with the following:

- Other services within East Lothian Council
- NHS
- Police
- Central Government or government agencies
- Courts
- Solicitors
- Professional forums
- Charities and advice organisations/third sector partner organisations
- Associations, such as Housing Associations
- Contractors
- Councillors
- Landlords, hostels and accommodation providers
- Carers

Your personal information will not be transferred outside of the EU, with the exception of those customers using prepaid cards. The supplier of this service uses third party processors based in the USA. East Lothian Council has inserted a clause into its contract that obligates the Supplier to bind the sub-processor to maintain GDPR-level data protection practices.

## Section 5: How long will we keep your personal information?

#### Section 6: Your rights

- 1. You have the right to be informed about how your information will be used.

- 3. You have the right to ask us to correct inaccurate or incomplete information.
- 4. In certain circumstances, you have the right to have your personal information erased.

- 6. In certain circumstances, you have the right to ask us to move, copy or transfer your information to another organisation in an electronic format.
- 7. In certain circumstances, you have the right to object to the ways we process your information.
- 8. In circumstances where your data is processed automatically, without human intervention, you have the right to certain protections.
