Call for Sites

As part of the development of the LDP there will be a call for sites exercise. This process is to identify sites which stakeholders think should be included in the spatial strategy for the next LDP.

The call for sites will run for 8 weeks, starting during the week beginning the 24th June until the week of the 19th August.

The exercise is to seek suitable sites for any use; employment, housing, retail, drive throughs and also community facilities such as allotments, cemeteries and sports facilities. Sites can also be submitted for renewable energy developments, woodland planting and other environmental improvements.

By submitting a site, this does not mean that the site will automatically be included in LDP2. All sites will be assessed by the Council against its site assessment methodology to determine their suitability for inclusion in the LDP spatial strategy.

Those responding to the call for sites must provide the required information in the required format for their sites to be considered in the LDP2 process.

LDP2 Evidence Report



The LDP2 Evidence Report was to have been presented to Council on the 25th June 2024. However due to the General Election being called the Evidence Report has been delayed.

The LDP2 Evidence Report will now be presented to Council on the 20th August 2024.

If approved, it will then be submitted to the DPEA for the Gatecheck process.

Self-Build Register

The Scottish Government requires Local Planning Authorities to prepare and publish a list of people seeking land for self-build housing in their area. Self-build housing is where an individual (whether acting alone or with other individuals) commissions or is personally involved in the design and construction of a dwelling that is intended to be the individual's main residence once it is built.

By signing up to our list, you will help us find out more about the demand for self-build plots in East Lothian, where people would like their plot to be and the type of house that they would like to build. We will use the information to explore ways in which it might be possible for people and plots to be brought together. **Registration does not however guarantee that a suitable plot will be identified, or become available for you.**

If you are seeking land for self-build housing in East Lothian and would like to register for the Self-build list, please complete the online registration form held on the Council's website.

Local Place Plans

Local Place Plans are a way for communities to engage creatively with the planning process and set out their own vision for their local areas.

These are optional plans that are prepared by local communities that have a focus on land use and 'place-making' within a chosen area.

For a Local Place Plan to be considered alongside the development of LDP2 we asked that Local Place Plans should be submitted for validation in May 2024. However, a LPP can be submitted at any time to the Council and will still be a valid consideration in the preparation of the proposed plan.

In addition to the statutory duties that we have in relation to progressing Local Place Plans, we can offer a range of support for communities that wish to undertake a Local Place Plan. This includes:

- general advice and guidance on the process, how to gather evidence, getting people involved and policy development,
- attendance at specific community body meetings, as required and if resources are available,
- assistance with mapping for consultation events and documents
- Helping to locate Local Place Plan guidance and other practical documents.

If your community wishes to produce a Local Place Plan or has already begun one then we would encourage you to contact the Policy team at LPPS@eastlothian.gov.uk to discuss timescales.

Local Biodiversity Site Condition Monitoring



The Council has partnered with Scottish Wildlife Trust to carry out a programme of monitoring of the condition of our Local Biodiversity

Sites. Volunteers will be going out over the summer/autumn from this May to end October 2024 and again in 2025. Short Term Lets

The Scottish Government has introduced Regulations that allow for greater control of short term let accommodation.

These Regulations also allow for control areas to be introduced, within which planning permission would be required. These control areas could be introduced due to a variety of reasons including: impact on the availability of housing stock, anti-social behaviour, amenity issues or the impact on the character of a neighbourhood. In addition, a requirement for short term lets to be licenced has come into force with all short term let's being required to apply for a licence by the end of October 2023.

Through the implementation of this licence scheme a more definitive figure on the number of short term lets will be gathered. Subsequently, Council officers will present a recommended approach to Council on whether control areas should be introduced. This will be in late 2024 or early 2025.
