#### Situation:

Brewery Park Business Centre is situated in Haddington town centre, just to the south of High Street. The refurbished office is located in Block B, within the John Muir House campus.



### **Description:**

Brewery Park Business Centre is a refurbished building comprising 10 offices. Room 1 is located on the ground floor and access is via the door to the front of the building.

The room itself is bright, with two large windows and is carpeted throughout. There is also electric heating. Entry to the centre is via a shared main entry door, with shared toilets and a disabled WC. The maximum occupancy for Room 1 is three people.

#### Rent:

We are seeking offers in excess of £4,210 p.a. (£350/month). The rent will be inclusive of charges for electricity (power and heating), building insurance, water use and cleaning of common areas. It does not include business rates, water sewerage and draining charges – see note under "Rating Assessment".

#### Use:

This property has Class 4 (Business) use. Any persons wishing to change the use of this property out with Class 4 must consult East Lothian Council's Planning Department and submit details of their proposed use and alterations along with their offer of rent.

The Rateable Value of the subjects has been assessed at £2,000 per annum.

Only those who have returned a completed Expression of Interest form will be notified of the closing date.


#### Legal Fees:

The ingoing Tenant will pay East Lothian Council £200 (+VAT) administration fee towards the preparation and completion of the lease.









