# Progress to date

In our last briefing in July, we detailed the outcomes of the options modelling exercise; where of the 61 short listed options:



**16 options** are recommended to proceed to the options appraisal.



**40 options** are regarded as action already underway / business as usual.



**5 options** are recommended to be withdrawn from further consideration at this point.

On Tuesday 30 July, 7 project team members and 11 independent community panel representatives took part in the options appraisal exercise, scoring the identified 16 options across three key themes, which were weighted as follows: desirability 35%, feasibility 35% and viability 30%.

## Identified priorities

As a result of the options appraisal exercise, the following four priorities were identified:



1. Review of palliative and end of life care throughout East Lothian including development of an end-of-life care sheet. (Option 11 and 14)



2. Introduction of polypharmacy reviews that are not exclusive to care home settings. (Option 95)

3. Investment in existing intermediate care services, including stepdown, and development of new intermediate care approaches.

(Option 77, 79 and 80)



4. Explore better use of technology and associated services to allow people to remain within their own homes for longer. (Option 85)
