**1 PURPOSE**

- 1.1 To advise Members on financial assistance to be awarded through the Sports Award Scheme to talented sportsmen and women competing and training outwith the UK and to teams who have competed successfully in national events qualifying them for additional competition either within or outwith the UK.

**3 BACKGROUND**

- 3.1 Jamie McHardy is member of the Scottish Men's Volleyball Team that played in the Novetol Cup in Luxembourg from 6-8 January 2012, against teams from Luxembourg, Denmark and England. Following a very close competition with three countries having won two and lost one match, Scotland emerged victorious by virtue of the most sets won.

- 3.2 Bartosz Andrzejewski, Murdo Lunn and Ross Lunn have all been selected to compete in the JKA Karate European Junior Championships in Paris, France from 2-3 June 2012.
- 3.3 Gavin and Brad Robertson have both been selected to compete for Scotland in the World Tae Kwon-Do Championships being held in Ottawa, Canada from 6-13 August 2012. These are only held every two years and selection is based on results gained in specific competitions. Brad, who will compete as a Junior, has been selected to compete in all four disciplines of Tae Kwon-Do, a significant achievement.
