1 PURPOSE

Windygoul Primary School – amendment of the number of places reserved from all places in the school to five reserve places at each stage in P1 – P7.

- 3.2 The Committee also agreed to delegate any changes to the number of places held in reserve to the Executive Director, in consultation with the
