1 PURPOSE

1.1 To note the decision to award the contract for the Proposed Demolitions and Enabling Works at Millhill Lane, Musselburgh to Messrs RM Brown Demolitions Ltd, Tranent.

2 RECOMMENDATIONS

2.1 Cabinet is asked to note the decision of the Head of Development in consultation with the Head of Council Resources to accept Messrs RM Brown Demolitions Ltd's tender amounting to £57,328.00 after checking and noting that it is open for consideration until 23rd July 2014 for the Proposed Demolitions and Enabling Works at Millhill Lane, Musselburgh.

3 BACKGROUND

- 3.1 The Council proposes to provide a new residential and resource centre for children aged 12 18 at Millhill in Musselburgh. This will replace the current provision located at St Joseph's in Tranent, the lease for which expires in February 2015. The main works will be procured as a Design and Build contract to contractors in Lots 3 and 4 on the Council's Framework Agreement for Various Construction Works. These enabling works are designed to provide a cleared site to allow the main works to commence on site timeously when awarded to ensure completion of the centre by February 2015.
- 3.2 Tender Documents were prepared and issued to the four undernoted selected Contractors and the following offers were duly received. All tenders were subjected to detailed checks and contractors were requested to clarify the basis of pricing in relation to elements of the proposed enabling works to ensure equal tendering. The final tender amounts are indicated overleaf:

3.3 As indicated at 3.2, Messrs RM Brown Demolitions Ltd's tender amounting to £57,328.00 after detailed checking remains the lowest of the offers submitted and has been competitively priced throughout.

The original Budget Cost Estimate for these works was circa £60,000.00.

- 3.4 Messrs RM Brown Demolitions Ltd, Tranent do not intend to use any domestic Sub-Contractors.
- 3.5 The Contract is prepared on a firm price basis in terms of the Minor Works Building Contract for Use in Scotland 2011 Edition (SBCC/MW/Scot) issued by the Scottish Building Contract Committee, and the Contractor has undertaken to complete the works within 6 working weeks from the date of possession.
