1 PURPOSE

1.1 To inform Members of the steps taken to procure the above Infrastructure – Road Services Contract and provide details of the work.

2 RECOMMENDATIONS

2.1 That Members note the decision of the Head of Infrastructure to award the contract for Carriageway Structural Repairs & Overlay – U116 Windymains to M&M Road Surfacing Limited, 9a Bankhead Medway, Sighthill Industrial Estate, Edinburgh, EH11 4BY. In accordance with the revised Scheme of Delegation (Appendix 2 to Standing Orders) section 1.11 Financial Limits and Section 4.6(f) of the Scheme of Delegation.

2.2 This report is submitted to the Members Library service in accordance with Standing Order 3.4 (a) and (c) for Members' information.

3 BACKGROUND

3.1 The winning tender was utilised by East Lothian for the provision of carriageway structural repairs & overlay on the U116 at Windymains sawmill.

3.2 The Quick Quotes were published via Public Contracts Scotland on 18th July 2014 with a return date of 29th July 2014.

3.3 In accordance with the Council's Corporate Procurement Policies and Procedures tenders were subsequently issued to three tenderers, with only two returning. These were then assessed to determine the most financially advantageous tender.

3.4 The evaluated tender results are as follows: -
