SUBJECT: Membership of the East Lothian Strategic Planning Group

1 PURPOSE

1.1 This report advises the Integration Joint Board of the legislative requirements as to the membership and proceedings of the Strategic Planning Group.

2 RECOMMENDATIONS

The Integration Joint Board is recommended to:

- 2.1 Agree the Strategic Planning Group membership proposals;
- 2.2 Agree to progress appointments as outlined.

3 BACKGROUND

- 3.1 Section 32 of the Public Bodies (Joint Working) (Scotland) Act places a duty on an Integration Joint Board (IJB) to establish a Strategic Planning Group (SPG) which must be involved in all stages of developing and reviewing the Strategic Plan.
- 3.2 The IJB is responsible for appointing members to the SPG and, where appropriate or necessary, removing or replacing members.
- 3.3 The legislation and supporting regulations prescribe the groups who must be represented on the SPG. The group should involve members nominated by the Local Authority and the Health Board. IJBs are also required to involve a range of stakeholders in the strategic planning process the standard consultees and can appoint others as it feels appropriate and necessary.

- 3.4 Section 32 of the Act prescribes that the following must be members of the SPG:
 - a. At least one person nominated by the Health Board
 - b. At least one person nominated by the local authority
 - c. A person to represent the interest of each locality
 - d. Representatives of groups prescribed by Regulation (see 3.7)
- 3.5 In respect of locality representatives, the IJB may select a single person to represent two or more localities.
- 3.6 The IJB is responsible for determining the procedure of its Strategic Planning Group.
- 3.7 The groups prescribed by regulation are:
 - a. health professionals
 - b. users of healthcare
 - c. carers of users of healthcare
 - d. commercial providers of healthcare
 - e. non-commercial providers of healthcare
 - f. social care professionals
 - g. users of social care
 - h. carers of users of social care
 - i. commercial providers of social care
 - j. non-commercial providers of social care
 - k. non-commercial providers of social housing
 - I. third sector bodies carrying out activities related to healthcare or social care

Those members detailed in b, c, g and h (above) must reside within the area of the local authority. Others must operate within the area of the local authority.

- 3.9 The Strategic Planning Group will be the forum which provides a mechanism for all partners to define and develop the Strategic Plan which will deliver local success against the national outcomes for health and wellbeing. As such the SPG will need to be fit for purpose and have a membership and infrastructure which addresses the challenges of effective strategic planning for the wide ranging scope of delegated functions. Members of the SPG should equally be required to demonstrate an effective constituency or reference group in order to ensure involvement and engagement.
- 3.10 Whilst there is a broad representation of interests on the shadow SPG there remain a small number of membership places to be filled. These are set out in Appendix 1a and in each case a recommendation is made as to how the situation should be addressed.

- 3.11 The Vice-chair of the IJB will act as the Chair of the Strategic Planning Group.
- 3.12 East Lothian's SPG has been operating effectively in shadow form since November 2013 in order to progress consultation drafts of the Strategic Plan. As outlined in 3.9, it has since been recognised that membership of the shadow SPG should be strengthened in order to provide the comprehensive intelligence base which will deliver a robust Strategic Plan for East Lothian. As such this paper recommends that the IJB agrees proposals to enhance the current membership by appointing additional members as outlined in Appendix 1b.
- 3.13 In addition to considering appropriate membership there is a need to agree a defined remit and terms of reference for the Group. A proposed draft is attached as Appendix 2.
- 3.14 A wider review of East Lothian's current joint planning structures is being finalised and recommendations from this will be brought forward to the IJB imminently. As a minimum it is recommended that the SPG receive briefings from each care planning group at least annually, and, in addition, organise an annual Strategic Planning conference in East Lothian to build meaningful involvement and engagement.

4 POLICY IMPLICATION

4.1 The implementation of recommendations made in this report will ensure that the IJB complies with all legal requirements.

DRAFT Role and remit

- To act as the main planning governance group on behalf of East Lothian IJB, developing key strategic priorities in the process
- To understand the level of need within the local health and social care economy
- To work towards reducing health inequalities across the county and ensure that appropriate actions are incorporated into the Strategic Plan and component local agency strategies and plans
- To commission strategic health assessments and other research to monitor progress in improving health outcomes
- To produce and maintain the Strategic Plan
- To support the delivery of agreed national and local targets in respect of health and social care
- To scrutinise and monitor the impact (or planned impact) of health and social care strategies on the people of East Lothian
- To maintain effective links with other partnerships in areas of joint concern
- To respond to IJB strategic priorities and in turn influence these to support effective alignment of IJB, NHS Lothian and SOA plans.
- To set the tone and direction for partnership working
- To oversee and monitor progress with the implementation of the strategic plan

Meetings of the Strategic Planning Group will be chaired by the Vice Chair of the IJB

Officers will be in attendance at meetings in an advisory capacity.

Meeting Frequency

The Strategic Planning Group will meet four times within a financial year. An extraordinary meeting will be called when the Chair considers this necessary.
