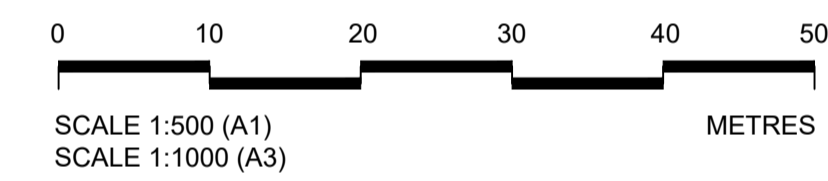


CROSS-SECTION B-B

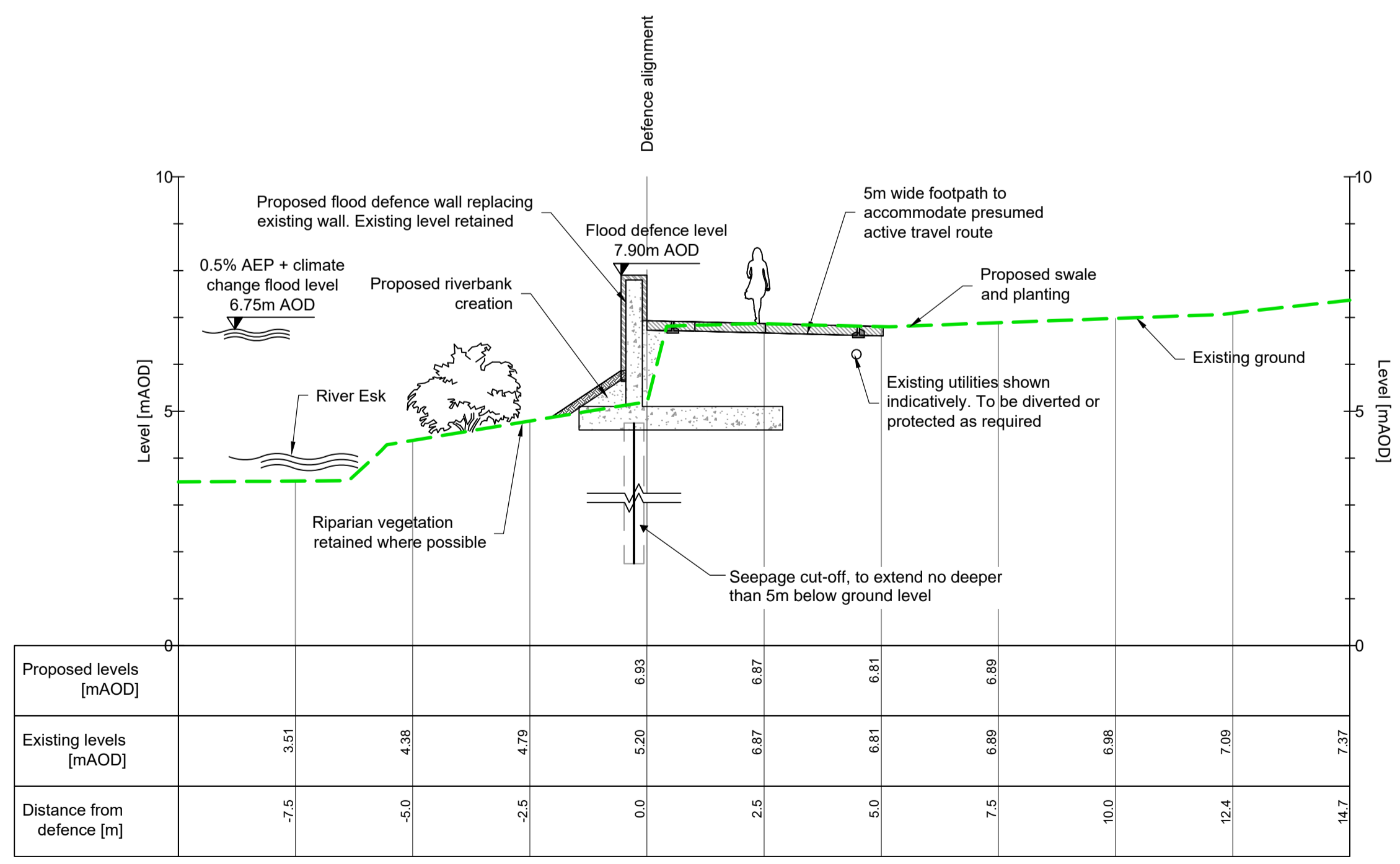

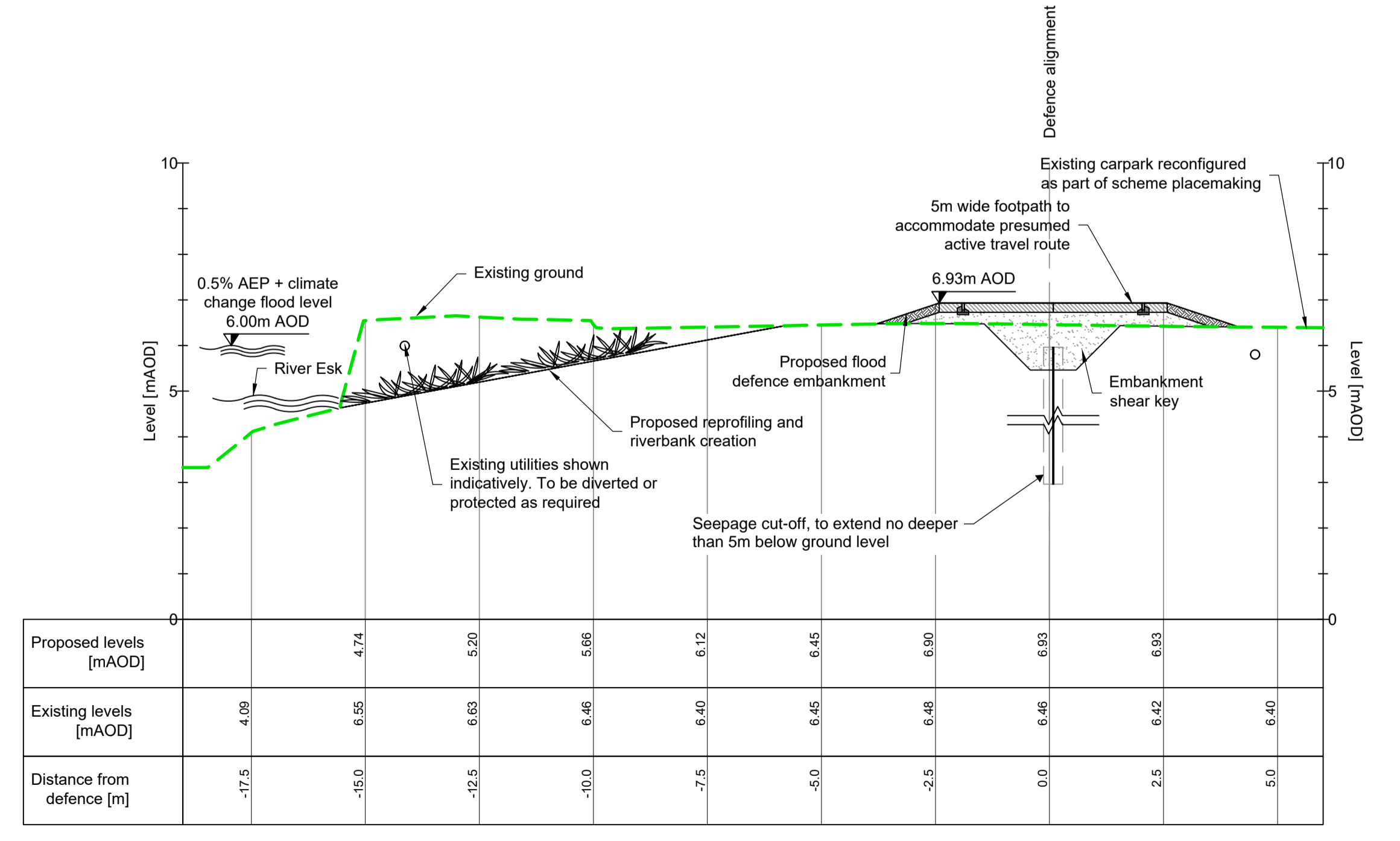

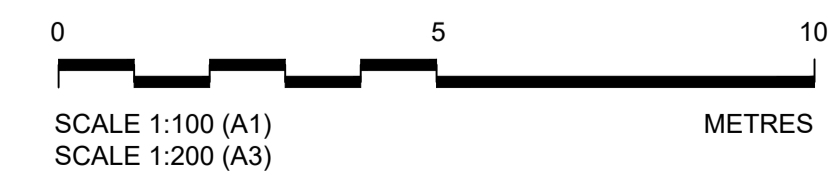
